

Privacy Policy

The following English translation is unofficial and only for information. In any case of a dispute the official Hungarian version is valid.

Chronomoto Kft. (tr.no.: 01-09-731652, addr.: H-1213 Budapest, Hollandi út 13., e-mail: auto@chronomoto.hu, as Operator) manages the user's personal data providing online registration service exclusively for registration to the **XIV. Mercedes-Benz Star Tour oldtimer event**. Operator manages only those data which are necessary to participate at the event. It manages the data until and no more than it is necessary.

The managed personal data and the aim of management:

Operator respects Privacy Policy rules during the management, processing and forwarding the data.

The participant contributes by the online registration as per the Act CXII of 2011 (Hungary) on information self-determination and freedom of information (Infolaw) 5. § (1) a) as he/she has voluntarily given personal data to be managed by Operator.

Potential operators to access and handle data:

- Event organizer of Mercedes-Benz Star Tour from Chronomoto Kft.
- Administrative contributors of Mercedes-Benz Hungária Kft.

Period of data management: the stored electronic personal data will be deleted after five years from Operator's database.

The participant has the rights according to the Infolaw during data management and processing, therefore, he/she has the right to ask for information, request for data correction, delete, distraint, and he has the right of legal redress. In case of violating these rights the participant can go to court against Operator, or to the Hungarian National Authority for Data Protection and Freedom of Information (addr.: H-1125 Budapest, Szilágyi Erzsébet fasor 22/c, www.naih.hu). Furthermore, the participant can protest against the management of his/her data, which can be requested by written statement directed to the Operator, or he/she has the right to dismiss the privacy policy. In this case the participant can not take part in the event.

Participant can ask information or ask to delete his/her personal data of registration in an e-mail sent to Operator. He can modify data during a new registration or ask for modification in e-mail (auto@chronomoto.hu). If Operator finds participant's request is legitimate, then starts the modification or delete process immediately.
